QUALIFICATIONS

TO QUALIFY FOR A PARKING DECAL, A STUDENT MUST HAVE THE FOLLOWING:

1. A GPA OF A MINIMUM OF 2.0 BASED ON MOST RECENT REPORT CARD
2. A VALID DRIVER'S LICENSE (WITH PRIORITY GIVEN TO UPPER CLASSMEN AT THE START OF SCHOOL)
3. A CURRENT VEHICLE REGISTRATION AND INSURANCE CARD IN THE DRIVER'S OR VEHICLE OWNER'S NAME
4. NO OUTSTANDING SCHOOL FINANCIAL OBLIGATIONS
5. NO EXCESSIVE OR SERIOUS REFERRALS. NO UNSERVED DETENTIONS OR ALTERNATIVE EDUCATION (IN SCHOOL SUSPENSIONS)

\$45 YEARLY FEE FOR ALL STUDENTS

\$45 IF DECAL IS LOST OR SEE MRS. TURNGREN OR MRS. MALLORY IF THE DECAL HAS BEEN LOST DUE TO AN AUTO ACCIDENT/AUTO THEFT TO DISCUSS REPLACEMENT DECAL COST

REVOCAION

A STUDENT'S PARKING PRIVILEGE MAY BE REVOKED FOR ONE OF THE FOLLOWING REASONS OR IF THE SCHOOL ADMINISTRATION OR SCHOOL RESOURCE OFFICER FIND IT NECESSARY:

1. FAILURE TO MAINTAIN A 2.0 GPA.
2. MORE THAN 2 REFERRALS WITHIN A 9 WEEK PERIOD OR ANY MAJOR INFRACTION ON CAMPUS OR WHILE INVOLVED IN ANY SCHOOL/COUNTY EVENT.
3. UNEXCUSED ABSENCES/EXCESSIVE TARDIES.
4. PERMITTING ANOTHER STUDENT TO USE YOUR ASSIGNED DECAL OR GIVING FALSE INFORMATION ON YOUR APPLICATION.
5. LEAVING CAMPUS WITHOUT AUTHORIZATION OR A CHECK OUT PASS.
6. TAKING ANOTHER UNAUTHORIZED STUDENT OFF CAMPUS WITHOUT PARENTAL/SCHOOL CONSENT.
7. USE OR DISTRIBUTION OF AN UNAUTHORIZED OR DUPLICATED DECAL
8. RECKLESS DRIVING AND/OR SPEEDING IN THE PARKING LOT (SPEED LIMIT IS 5 MPH) OR WITHIN THE PERIMETER OF THE SCHOOL.
9. FAILURE TO SERVE DETENTIONS, OR ALTERNATIVE EDUCATION (IN SCHOOL SUSPENSION)
10. EXCESSIVE PARKING VIOLATIONS.
11. LOUD AND/OR PROFANE MUSIC
12. ALL VEHICLE DOORS MUST BE LOCKED WHILE IN THE PARKING LOT FOR SECURITY REASONS. RANDOM MONTHLY CHECKS ARE DONE. ANY VEHICLE FOUND UNLOCKED WILL BE SUBJECT TO A \$20 PARKING FINE.

TRANSFER OF PARKING DECAL

TO TRANSFER A PARKING DECAL FROM ONE VEHICLE TO ANOTHER, THE STUDENT MUST HAVE THE CURRENT REGISTRATION TO THE NEW VEHICLE ON FILE IN THE 9TH GRADE CENTER.

MISCELLANEOUS

1. STUDENTS MUST EXIT THEIR VEHICLES UPON ARRIVAL. STUDENTS ARE NOT ALLOWED IN THE PARKING LOT DURING THE DAY WITHOUT ADMINISTRATIVE APPROVAL (INCLUDES LUNCH)
2. DECALS ONCE ISSUED MAY NOT BE ALTERED. THEY MUST HANG FROM THE REAR VIEW MIRROR AND BE CLEARLY VISIBLE.
3. IT IS THE RESPONSIBILITY OF THE STUDENT TO KNOW THE GRADE LEVEL OF HIS PASSENGERS. REMEMBER-LEAVING CAMPUS FOR LUNCH IS ONLY A SENIOR PRIVILEGE (w/approved app!)
4. THE ADMINISTRATION OF SPRUCE CREEK HIGH SCHOOL RESERVES THE RIGHT TO MAKE REASONABLE ADJUSTMENTS IT DEEMS NECESSARY TO ENFORCE STUDENT PARKING REGULATIONS TO ENSURE THE SAFETY AND PROTECTION OF THE STUDENT POPULATION. FLORIDA LAW PROVIDES FOR SEARCH OF ANY VEHICLE ON CAMPUS BY THE SCHOOL ADMINISTRATION/DEPUTY UPON REASONABLE SUSPICION THAT A CRIME HAS OR IS ABOUT TO OCCUR.
5. TO ENSURE THE SAFETY AND PROTECTION OF OUR STUDENTS WHEN LEAVING THE PARKING LOT, ABSOLUTELY NO LEFT TURNS ON TO CLYDE MORRIS BLVD.
6. FAILURE TO FOLLOW PARKING POLICIES WILL RESULT IN EITHER PARKING FINES, \$20 PER VIOLATION OR REVOKING THE PRIVILEGE TO PARK ON CAMPUS. VIOLATIONS COULD RESULT IN THE VEHICLE BEING TOWED AT THE OWNER'S EXPENSE. VIOLATIONS MAY BE ISSUED BY ANY OF THE CAMPUS ADVISORS OR THE DEPUTY.
7. ABSOLUTELY NO PARKING IN THE MOTORCYCLE/MOPED PARKING SPOTS BY STUDENTS DRIVING AUTOMOBILES.

NEITHER SPRUCE CREEK HIGH SCHOOL NOR THE SCHOOL BOARD OF VOLUSIA COUNTY ARE RESPONSIBLE FOR ANY THEFT, FIRE, DAMAGE, VANDALISM AND/OR MISHAP THAT MAY OCCUR TO ANY VEHICLE PARKED ON THE SPRUCE CREEK HIGH SCHOOL CAMPUS.
