## Volusia County Schools 1:1 Program Information & Acknowledgement

The focus of Volusia County Schools 1:1 device program is to provide tools and resources to the 21<sup>st</sup> Century student. Technology within education should have one basic goal: *to enhance and positively support the learning environment*. Increasing access to technology is essential for our students' future. Volusia County Schools respects families' rights to make educational decisions for students. Volusia County Schools will provide digital access to your student to complete their schoolwork in person or via remote. It is strongly recommended that families check out the district provided device from their school.

**Option 1: 1:1 Device Check-Out & Acknowledgement**

To receive a device, students and parents must comply with the following:

I understand that

- *This device is not my property, but the sole property of the Volusia County School District and that VCS has the right, at its sole discretion, to retrieve this device from me at any time, with or without cause and with or without prior notice to me.*
- *The intended sole use of the device is for educational purposes, only. All use of the device must abide by the VCS Conditions of Acceptable Use and is subject Volusia County School Board Policy 518 (I, II).*
- *If the technology device is damaged and/or not working properly:*
  - *Report it to your teacher within 24 hours*
  - *A collaborative investigation of the incident that resulted in the damage will be conducted*
  - *The repair/replacement of the technology device and/or any accessory may be at your own expense*
- *If the device is stolen:*
  - *File a police report within 24 hours*
  - *Provide a hard copy of the police report to the school within 24 hours of filing the police report.*
- *I must return the device to the school upon request for check-in or return*
- *If I leave my school for any reason, including internal district transfer, the device must be returned to the school I am leaving*

**Option 2: Bring Your Own Technology (BYOT)**

Each student is afforded the opportunity to receive a high-quality, durable device from Volusia County Schools. The student device will serve as a hub for Volusia County Schools’ instructional materials, software programs, and digital resources. *Some of these resources, may not be available and fully functioning on a personal device.* It is important to note; the laptop must be logged in with a Volusia County School ID.

**Please acknowledge below that you refuse to accept the device being provided by the district & that you will bring your own technology to school, daily.**
